The sixth edition provides explicit rules for direct quotations and states that you must credit the source when “paraphrasing, quoting an author directly, or describing an idea that influenced your work” (p. 170). If the quotation is less than 40 words, incorporate the quotation into the text and place quotation marks round the quotation.

A "hanging indent" means that each subsequent line after the first line of your citation should be indented by 0.5 inches. Instead, the Publication Manual, Sixth Edition states that "for substantial reference works with a large editorial board, naming the lead editor followed by et al. is acceptable" (p. 184). In other words, you can cite either all of the editors' names or just the first one followed by et al.

### Formatting Your Paper - Citation Help for APA, 6th Edition ...

APA Style uses parenthetical, author-date citations. After a quote, add parentheses containing the author's name, the year of publication, and the page number of the work. For quotations that are on one page, type "p." before the page number, and for quotations that start on one page and end on another page, use "pp." as in the examples below.

### APA 6th Ed: In-Text Citations - Citation Resources ...

When there is no author your in-text and parenthetical citations should begin with the first couple words of the title and include the year of publication. When citing books, videos, brochures, journals, reports, etc. italicize the title. When citing web pages, journal article titles, or chapter titles use quotation marks around the title.

### In-text Citations - Citation Help for APA, 6th Edition ...

If an item has no author, start the citation with the article title. When an article has one to seven authors, all authors' names are cited in the References List entry. When an article has eight or more authors list the first six authors followed by three spaced ellipse points (...), and then the last author's name.
