The pharmacist in charge shall be assisted by a sufficient number of pharmacy technicians, as defined in 114002-.02, pharmacy interns, and other supportive - personnel as may be required to operate the pharmacy competently, safely, and adequately to meet the needs of the patients served by the long-term care facility. Effective October 1, 2013, a new Tennessee law (T.C.A. § 53-11-308) set a limit on the amount of Schedule II and III drugs being prescribed or dispensed for a 30-day supply. This regulation will also require practitioners to assess patients for substance misuse by conducting urine drug testing at least every thirty days if they prescribe Schedule II or III drugs alone or in combination beyond a thirty day period.

In order to reduce exposure and transmission of the COVID-19 virus, effective immediately the Tennessee Board of Pharmacy has waived the requirement for patients to be counseled face to face as stated in Rule 1140-03-.01 (1). Counseling may be provided by a pharmacist by telephone or by other forms of technology or by alternative means.

## **Pharmacy - Tennessee State Government - TN.gov**

Effective February 1, 2006, the TennCare Pharmacy Program revised the prescription limit program to allow adult enrollees to exceed the monthly 5 prescription or 2 brand limit for certain medications in high risk situations. This is in addition to over 600 hundred medications on the Automatic Exemption List that do not count towards limits.
